

PUBLIC NOTICE
SUMMARY OF ORDINANCES

Pursuant to Section 380.7 (2) of the Code of Iowa, notice is hereby given of the adoption of Ordinances #529, 530,531,532,533 and 534.

The following is a synopsis of the essential elements of Ordinance #529, “An Ordinance Amending The Code Of Ordinances Of The City Of Missouri Valley, Iowa By Amending Provisions Pertaining To Number Of Animals Limited”: Section 55.09 is amended to include provisions limiting the number of cats allowed per property to three. This pertains to indoor cats only.

The following is a synopsis of the essential elements of Ordinance #530, “An Ordinance Amending The Code Of Ordinances Of The City Of Missouri Valley, Iowa By Amending Provisions Pertaining To Lien Exemption”: Section 92.07 is amended to include a lien exemption for nonpayment of utility bills for mobile homes, modular homes, and manufactured homes owned by a tenant of and located in a mobile home park or manufactured home community when the owner or manager of the mobile home park or manufactured home community is the account holder.

The following is a synopsis of the essential elements of Ordinance #531, “An Ordinance Amending The Code Of Ordinances Of The City Of Missouri Valley, Iowa By Amending Provisions Pertaining To Litter”: The definition of “litter” is amended in Section 105.02 (6).

The following is a synopsis of the essential elements of Ordinance #532, “An Ordinance Amending The Code Of Ordinances Of The City Of Missouri Valley, Iowa By Amending Provisions Pertaining To Water Service Discontinued”: Section 92.05 is amended to include provisions for disconnection of water service in the event of non-payment of a utility bill.

The following is a synopsis of the essential elements of Ordinance #533, “An Ordinance Amending The Code Of Ordinances Of The City Of Missouri Valley, Iowa, By Amending Provisions Pertaining To All-Terrain Vehicles”: Section 75.05 is amended by adding a new subsection 6 to provide for a direct crossing of a highway by an all-terrain vehicle.

The following is a synopsis of the essential elements of Ordinance #534, “An Ordinance Amending The Code Of Ordinances Of The City Of Missouri Valley, Iowa, By Amending Provisions Pertaining To Cigarette And Tobacco Permits”. The definition of “place of business” is amended in Section 121.01 subsection 3 to include alternative nicotine products or vapor products. Section 121.05 is amended to provide that any application for permit be submitted to the Alcoholic Beverages Division of the Department of Commerce. Previously the applications were to be submitted to the Iowa Department of Public Health.

The above descriptions of Ordinances #529,530,531,532,533 and 534 are summaries.
